Candidates for the Council Board and the Board Development Committee must meet the following criteria:

1. Demonstrated commitment to the values and principles of Girl Scouting.
2. Enthusiasm for Girl Scouting and the Council, conviction about its mission, the willingness to develop expertise about the Council's ways of functioning, and to serve as an active advocate (including positions of leadership in Girl Scouting).
3. Recognition as a respected community leader with involvement in other community interests.
4. Willingness to give generously of her/his time, talent, and personal resources and to give Board participation a high priority.
5. Influence in generating financial support. Willingness to solicit and secure substantial contributions in support of Girl Scout.
6. Top management experience and organizational leadership experience.
7. Understanding and appreciation for the Board's role of governance versus the staff's role of day-to-day management of operations.

Candidates not selected for board membership may also be referred for task group appointments or other leadership positions.
